



ATTENDANCE | INTRODUCTION

The bylaws of the International Relations Students' Association (IRSA) mandate that Executive Members attend 80% of Executive Councils (§ 5.1.5). Per § 5.1.8.6 of the IRSA Bylaws, the President must be responsible for running Executive Councils; thus, in IRSA's 44th Year, the Office of the President ("the Office") has directed that Executive Member attendance be published to all Active Members in alignment with its transparency objectives.

As Active Members elect Executive Members, they retain the right to assess the fulfillment of Executive Members' mandates as prescribed by IRSA's Governance and to exercise their rights per the Alma Mater Society *Clubs and Societies Committee Policy Manual* to advocate for corrective measures. The Office regularly reminds all Executive Members of their attendance metrics by publishing this Attendance Documentation on the Association's website.

ATTENDANCE | METRICS

In the 44th Year of the Association, the Office balances Executive Member autonomy, their duty to Active Members, and recognition of their role's volunteer nature. Per its authority in § 5.1.8.6 of the IRSA Bylaws, the Office calculates attendance metrics as follows:

$$\frac{\text{Number of Times Present} + \text{Number of Regrets Sent}}{\text{Total Number of Executive Councils}} * 100\% = \text{Attendance Metric}$$

Where the Secretary notes down Executive Members as either:

- ❖ **Present.** Where Executive Members attend Executive Council at any point between its *call to order* and *adjournment*.
- ❖ **Regrets.** Where Executive Members notify the Secretary of their absence from Executive Council before the *call to order* without having to specify the reason for their absence.
- ❖ **Absent.** Where Executive Members do not notify the Secretary of their absence from Executive Council before the *call to order*.
